

# Park'N Fly Canada's 2009 Sweepstake Contest

### Full Contest Rules and Regulations

1. **CONTEST PERIOD:** The Contest begins at 12:01AM (ET) on Saturday, December 5, 2009 and closes at 11:59PM (ET) on Sunday, February 28<sup>th</sup>, 2010 (ET) (the "Contest Period").
2. **A) HOW TO ENTER:** No Entry required. Contest open to CAA members only. CAA Members need to complete a transaction with a participating Park'N Fly location during the period of the contest. CAA members are automatically entered, at time of check-out, members presenting their card at the cashier station will have a chance to win a trip for two.  
  
**B) HOW TO ENTER:** No purchase required.
