

Park'N Fly Canada's 2012 Sweepstake Contest

Full Contest Rules and Regulations

1. **CONTEST PERIOD:** The Contest begins at 12:01AM (ET) on Monday, April 30, 2012 and closes at 11:59PM (ET) on June 10th, 2012 (ET) (the "Contest Period").
2. **HOW TO ENTER:** No Entry required. Contest open to CAA members only. CAA Members need to complete a transaction with a participating Park'N Fly location during the period of the contest. CAA members are automatically entered, at time of check-out, members using their card at the cashier station will have a chance to win their stay for free

HOW TO ENTER: No purchase required. CAA members can forward a hand written drawn note with their name, address, telephone number along with their CAA membership number to the following address to be included in the random draw. Park'N Fly Canada, 5905 Campus Road, Mississauga, Ontario, L4V 1P9.

Requests must be received by June 10th, 2012 at 11:59PM (ET).

3. **PRIZES:** There are (4 weekly) Prizes available to be won each week, with a total of 24 prizes over the course of the contest. Each Prize in the Park'N Fly Contest consists of a free parking stay for up to 30 days. Approximate retail value of each Prize will vary depending on parking lot and city. The retail value of any parking stay will not exceed \$439.00.
4. Prize must be accepted as provided. The prize cannot be used in conjunction with any other promotion or offer and may not be separated and must be accepted as awarded, cash equivalent substitution will not be available.
5. Each Prize must be accepted as described in these rules and cannot be transferred to another person, substituted for another prize or cash, or exchanged in whole or in part, subject to the provisions set forth elsewhere in these rules.
6. **PRIZE winner selection:** The weekly prizes will be randomly drawn from each weekly stay or submitted entries between the periods of April 30th and June 10th. Odds of winning depend on number of eligible stays checking out on that particular draw date or number of entries received during the contest period.
7. **HOW TO WIN:** To be declared a winner of either a Prize, selected entrants must first correctly answer, unaided, a time-limited, mathematical skill-testing question, posed by telephone or email at a mutually convenient time. Eligible entrants providing an incorrect answer will no longer be eligible to win a prize in this contest. In addition, before being declared one of the winners of a Prize, each winner, will be required to sign a stand Release and Indemnity Form specific to the Prize confirming understanding, compliance with and acceptance of the contest rules and acceptance of the Prize as awarded and a release of all liability satisfactory to the Contest Sponsor(s) and return the signed form

Entrants who have not complied with these Official Rules are subject to disqualification.

10. Entrants and/or winners assume liability for injuries caused, or claimed to be caused by participating in the Contest, or by the acceptance, possession, or use of any prize awarded, including but not limited to claims/damages for personal injury, or property damage.
11. Contest Sponsor and the Promotion Entities do not warrant that access to or use of the service will be uninterrupted. Contest Sponsor and the Promotion Entities are not responsible for any problems that may arise.
12. Releases: By signing the stand and release form, winners confirm that they have read and understood these Rules. All documents must be completed and returned within the period noted on those documents or the prize may be forfeited.
13. Disclaimer: a) All entries become the property of the Contest Sponsor, who shall have no liability for lost, stolen, late or damaged. All entries are subject to verification and will be declared invalid if they are ineligible, incomplete, forged, falsified, altered or tampered with in any way.
14. Disclosures: Any attempt by an entrant or other individual, to undermine the legitimate operation of the Contest, including but not limited to any fraudulent claims, is a violation of criminal and civil laws. Should such an attempt be made, Contest Sponsor reserves the right to seek remedies and damages from any such individual, to the fullest extent permitted by law, including criminal prosecution. Participant engaging in any of the foregoing activities will be disqualified and will forfeit any prizes won.
15. The Contest Sponsor reserves the right to suspend, cancel or modify the Contest at any time.
16. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Contest Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the substantive laws of the Province of Ontario without regard to Ontario conflicts of law principles. All entrants consent to the jurisdiction and venue of the Province of Ontario.
17. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. In particular, Contest Sponsor's employees are not authorized to waive, modify or amend any provision or provisions of these Official Rules in any manner whatsoever.
18. Personal information collected from entrants will be used by the Contest Sponsor for the purpose of administering the Contest. Contest Sponsor will not sell, share or otherwise disclose personal information of entrants with third parties, other than to third parties engaged by Contest Sponsor to fulfill the above purposes or as permitted or required by law.
19. All entry forms become the property of the Contest Sponsor and will not be acknowledged or returned. The Contest Sponsor will not be responsible for entry forms delayed, stolen, misdirected, lost or destroyed.
20. By accepting one of the Grand Prizes in this contest, each Grand Prize Winner and, if under the age of majority, his/her parent or legal guardian, and the Travel Partner agree to hold the Promotion Entities, their affiliates, subsidiaries, advertising and promotional agencies, their respective directors, officers, employees and assigns, harmless from and against any and all claims and liability arising out of or in any way connected with the operation of this Contest and use of the Grand Prize.
