

Park'N Fly Toronto Valet 2012 Contest

“Park'n Play”

Full Contest Rules and Regulations

1. **CONTEST PERIOD:** The Contest begins at 12:01AM (ET) on Wednesday, January 25, 2012 and closes at 11:59PM (ET) on Wednesday, February 29, 2012 (ET) (the “Contest Period”). The contest is only open to Toronto Valet customers.
2. **HOW TO ENTER:** (A) Contest is open to Toronto Valet customers. Customers are automatically provided with a scratch and win card at time of check in during period of the contest. Limit one scratch and win card per transaction. Scratch and win card can only be picked up at time of check in. (B) No purchase required: Contestants can receive scratch and win card by visiting a valet location or by mailing a self-addressed stamped envelope and requesting a scratch and win card to: 5905 Campus Rd, Mississauga, ON L4V 1G2, Attention Park'n Play Team.
3. **PRIZES:** During the contest period, there are a total of 288 BlackBerry® 16 GB PlayBook™ tablets to be won or an average of 8 units a day. In addition there are a total of: 500 Free 7 day stays, 750 Free 3 day stays, 1,000 Free 1 day stay, 2,000 100 Park'N Fly Rewards Points to be won. The Free day stays are for the Toronto Valet location. Customer must be a Park'N Fly Rewards member to qualify for the 100 Park'N Fly Rewards Points.
 - I. Prizes are subject to availability and are available to be won until Wednesday February 29th.
 - II. Any expenses incurred due to being awarded the prize are the responsibility of the contest winner.
 - III. Prizes must be accepted as awarded, cash equivalent substitution will not be available nor can it be substituted for another prize or exchanged in whole or in part and cannot be transferred to another person.
