

Park'N Fly Canada's 2009 "I Want Sun" Contest

Full Vancouver Contest Rules and Regulations

1. **CONTEST PERIOD:** The Contest begins at 12:01AM (ET) on Friday Dec. 18, 2009 and closes at 11:59PM (ET) on Feb. 28, 2010 (ET) (the "Contest Period").
2. **HOW TO ENTER:** No purchase required. Consumers can forward a hand written drawn note with their name, address, telephone number and label it as "I want sun" to the following address to be included in the random draw. Park'N Fly 6380 Miller Road, Richmond, British-Columbia, V7B 1B3. Otherwise, a ballot can be picked up at the Valet location where it can be completed entered into the contest.
3. **PRIZES:** There are 2 prizes to be won. Each prize consists of land only, consisting of 4 nights/5 days at a Sandals resort plus all meals. Each Prize in the Park'N Fly Contest consists of a free parking stay for up to 8 days. Approximate retail value of each Prize will be approximately \$2500. Total prize value is \$5,000.
4. Prize must be accepted as provided. The prize cannot be used in conjunction with any other promotion or offer and may not be separated and must be accepted as awarded, cash equivalent substitution will not be available.
5. Each Prize must be accepted as described in these rules and cannot be transferred to another person, substituted for another prize or cash, or exchanged in whole or in part, subject to the provisions set forth elsewhere in these rules.
6. **PRIZE winner selection:** At the end of the contest period (Feb. 28, 2010) a random draw will be held on March 19th, at 3:00pm EST 6380 Miller Road, Richmond, British-Columbia, V7B 1B3, to select the 2 prize winners. Odds of winning depend on number of eligible entries during the contest period.
7. **HOW TO WIN:** To be declared a winner of either a Prize, selected entrants must first correctly answer, unaided, a time-limited, mathematical skill-testing question, posed by telephone or email at a mutually convenient time. Eligible entrants providing an incorrect answer will no longer be eligible to win a prize in this contest. In addition, before being declared one of the winners of a Prize, each winner, will be required to sign a stand Release and Indemnity Form specific to the Prize confirming understanding, compliance with and acceptance of the contest rules and acceptance of the Prize as awarded and a release of all liability satisfactory to the Contest Sponsor(s) and return the signed form

9. **Conditions of Entry:** Entrants (i) acknowledge compliance with these Official Rules including all eligibility requirements and, (ii) agree to be bound by the decisions of the Contest Judges, made in their sole discretion, which shall be final and binding in all matters relating to the Contest. Entrants who have not complied with these Official Rules are subject to disqualification.
10. Entries generated by script, macro, robotic, programming, or any other automated means are prohibited and will be disqualified. Sponsor is not responsible for late, lost, damaged, misdirected, mutilated, garbled, illegible or incomplete entries. Proof of transmission (screenshots or captures of game play etc.) and/or mailing does not constitute proof of delivery. All entries become the property of Contest Sponsor and in no case shall be returned to sender.

11. Entrants and/or winners assume liability for injuries caused, or claimed to be caused by participating in the Contest, or by the acceptance, possession, or use of any prize awarded, including but not limited to claims/damages for personal injury, or property damage.

Contest Sponsor and the Promotion Entities do not warrant that access to or use of the service will be uninterrupted. All such e-mail communications will contain an opt-out to be exercised at any time by the Contest Entrant.

Entrants also agree, should they become an eligible winner, that they will sign a Declaration of Compliance with the Rules, and a release form releasing the Contest Sponsor, and any respective affiliates, parents, subsidiaries, directors, officers, employees, agents and advertising and promotional agencies (collectively, the "Releases"), from any and all claims or liability of any kind arising from or in connection with this contest or a prize, including, without limitation, claims or liability in connection with the acceptance, use or misuse of the prize as awarded. All documents must be completed and returned within the period noted on those documents or the prize may be forfeited.

Should such an attempt be made, Contest Sponsor reserves the right to seek remedies and damages from any such individual, to the fullest extent permitted by law, including criminal prosecution. Participant engaging in any of the foregoing activities will be disqualified and will forfeit any prizes won.
16. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Contest Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the substantive laws of the Province of Ontario without regard to Ontario conflicts of law principles. All entrants consent to the jurisdiction and venue of the Province of British Columbia.
17. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. In particular, Contest Sponsor's employees are not authorized to waive, modify or amend any provision or provisions of these Official Rules in any manner whatsoever.

18. Personal information collected from entrants will be used by the Contest Sponsor for the purpose of administering the Contest. Contest Sponsor will not sell, share or otherwise disclose personal information of entrants with third parties, other than to third parties engaged by Contest Sponsor to fulfill the above purposes or as permitted or required by law. By providing your information and opting-in at the Contest website, Contest Sponsor may provide you with information relating to new and existing products, coupons, product sampling, and news regarding upcoming promotions. By entering the Contest, entrant consents to the manner of collection, use and disclosure of personal information as set out in the Contest Sponsor's Privacy Policies, which are available at www.qualitystreet.ca
