

Park'N Fly Canada's 2014 Sweepstake Contest

"Win CAA Dollars"

Full Contest Rules and Regulations

1. **CONTEST PERIOD:** The Contest begins at 12:01AM (ET) on Monday, September 15, 2014 and closes at 11:59PM (ET) on Friday, October 31, 2014 (ET) (the "Contest Period").
2. **A) HOW TO ENTER:** No Entry required. Contest open to CAA Members only. CAA Members need to complete a transaction with a participating Park'N Fly location during the period of the contest. CAA Members are automatically entered, at time of check-out.

B) HOW TO ENTER: No purchase required. CAA Members can forward a hand written drawn note with their name, address, telephone number along with their CAA membership number to the following address: Park'N Fly Canada, 5905 Campus Road, Mississauga, Ontario, L4V 1P9, to be included in the random draw requests must be received by Friday, October 31, 2014 11:59(ET).
3. **PRIZES:** There are 3 Grand Prizes available to be won. Each grand prize winner will receive 1,000 CAA Dollars, deposited directly into their CAA Dollars account.
4. **CONDITIONS ATTACHED TO THE PRIZE**
 - I. The prize cannot be exchanged, transferred or substituted for cash.
 - II. All PRIZE winner selection: The grand prize winners will be randomly drawn from all entries and stays submitted or occurred between the periods of Monday, September 15, 2014 and Friday, October 31, 2014. Draw date will take place on Monday, November 10, 2014 at 11:00 AM (EST). Odds of winning depend on number of eligible entries during the contest period.
 - III. The prize (1,000 CAA Dollars) will be awarded as CAA Dollars and will automatically be deposited into the Members valid CAA account. CAA Dollars can only used at a CAA office and applied to purchases available through CAA, such as travel.
 - IV. CAA Dollars prizes will be deposited into winners account within 30 days of draw date.
5. Prize must be accepted as provided. The prize cannot be used in conjunction with any other promotion or offer and may not be separated and must be accepted as awarded, cash equivalent substitution will not be available, nor can it be transferred to another person.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Contest Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the substantive laws of the Province of Ontario

without regard to Ontario conflicts of law principles. All entrants consent to the jurisdiction and venue of the Province of Ontario.

In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. In particular, Contest Sponsor's employees are not authorized to waive, modify or amend any provision or provisions of these Official Rules in any manner whatsoever.
18. Personal information collected from entrants will be used by the Contest Sponsor for the purpose of administering the Contest. Contest Sponsor will not sell, share or otherwise disclose personal information of entrants with third parties, other than to third parties engaged by Contest Sponsor to fulfill the above purposes or as permitted or required by law. By providing your information and opting-in at the Contest website, Contest Sponsor may provide you with information relating to new and existing products, coupons, product sampling, and news regarding upcoming promotions. By entering the Contest, entrant consents to the manner of collection, use and disclosure of personal information as set out in the Contest Sponsor's Privacy Policies.
